#### REPORT OF THE COUNCIL FOR THE YEAR ENDED 31 DECEMBER 2004

Presented to members of the Association on the occasion of the Twenty Sixth Annual General Meeting held at Sasol Club, Secunda, on Thursday 24 February 2005 at 11:00.

#### RENEWAL PROCESS

Your Council has continued to focus on the Association becoming an effective role player in the Coal Mining Industry. This process would be ongoing as the Council wished to ensure that the Association was effectively marketed and participated in the preparation of new legislation and Codes of Practice.

Your Council will meet in April 2005 to assess the progress and to ensure that the objectives are obtained.

As part of the process the Council issues a Newsletter after each Council meeting giving members some insight into Council affairs and updating members on the Association activities.

# FINANCE

The financial statements appended to this report show that revenue for the year amounted to R201 782, made up of subscriptions received during the year from Full and Student members, interest received from investments with the Chamber of Mines' Cash Management Department, and the successful safety workshop and golf day. Expenditure amounted to R180 617. Accumulated funds at the beginning of the year totaled R199 397 and with the transfer of the current year's net surplus of R21 165 an amount of R220 562 will be carried forward to 2005.

As part of the Association's objectives a successful golf day was held in October 2004 and the funds generated are included in the current net surplus for 2004. The event also promoted fellowship amongst members. A safety workshop was held in October 2004 which also generated funds for the Association.

The accumulated funds have been used to fund the Association's initiative on the position of the certificated engineer, licensing and registration.

#### **SUBSCRIPTIONS**

In terms of the Powers vested in it by the Association's Constitution and Rules, Council has agreed to increase the annual subscriptions for the ensuing year for Full and Affiliate members to R565 (exclusive of VAT). The subscription for student members will be R165 (exclusive of VAT).

#### **MEMBERSHIP**

The membership of the Association as at 31 December 2004was 170(170), made up of 143(145) Full members, 1 (0) Affiliate members, 15(17) Student Members, 10(4) Honorary Life members and 1(1) Honorary Associate member.

Membership certificates are issued to new Full members of the Association on a bi-annual basis.

#### **MEETINGS**

In addition to the monthly meetings of Council, Regular Regional Meetings were held during the year and feed-back from members through their Regional Representatives and Council members, provided valuable assistance to the workings of Council. The increased involvement required by your Council in a number of important areas meant that Council meetings were held on a monthly basis.

During the year under review, Kwazulu Natal Regional meetings were combined with those of the Southern Region of the South African Colliery Managers' Association took place, to the benefit of both Associations.

The nine Council and six Regional Meetings were well supported during the year and the commitment by members to the Association is a positive sign for the future well being of the Association and its activities.

During the year the Association held a joint General Meeting with the Association of Mine Resident Engineers in August 2004. This was well supported and provided the opportunity to share experiences with members.

Once again your President was invited to attend Council Meetings of the South African Colliery Managers' Association and wishes to thank its President, Mr J P Jordaan for maintaining close ties between the two Associations.

#### TECHNICAL VISITS

During the year members attended a technical visit to SAA Maintenance Facility and to BMW. These were fairly well attended by some members, however other members did miss an important opportunity to review their facilities.

Council will continue to seek out interesting and diverse technical visits for members and give then the opportunity to experience other companies operations.

#### **MEETINGS OF PRESIDENTS AND VICE-PRESIDENTS**

The Association was again well represented at the inter-Association meetings of Presidents and Vice-Presidents, held in June and November 2004.

This meeting continued to serve as a useful forum where matters of mutual interest and concern have been addressed, not only with other mining disciplines, but also with the President and senior representatives of the Chamber of Mines.

Your Association has once again been actively involved in the 2004 Colliery Safety and Health Campaign launch which took place on 11 March 2004 and remains fully committed to the Campaign's ideals for the promotion of safety and health in the Mining Industry.

#### SENTINEL MINING INDUSTRY RETIREMENT FUND

The Association has actively participated through the South African Colliery Managers' Association's Trustee on the Sentinel Mining Industry Retirement Fund.

#### MINERALS ACT AND REGULATIONS

#### MQA AND ECSA

Your Association continues to have a very active role in the MQA and ECSA. During the year the following progress was made:

- The two stage model for engineering practitioners was accepted by MQA and ECSA.
- The three source document relating to the level 5 to 8 qualification design, registration and licensing as an elective option were accepted by MQA.
- Unanimous agreement/support by the stakeholder groupings of the three categories of "Engineering Work in the SA M&MS that will be reserved for persons registered with ECSA ("compulsory registration") at an Identification of Engineering Work Workshop held on 14 June 2004 under the auspices of the M&M SGB and the ENG 5-8 W/G:
  - I. Engineering design and synthesis of materials, components, systems or processes subject to the nature and type of design specified.
  - II. Education, Training and Development of learner practitioners who are registered with ECSA in terms of Section 18 (1) (b) of the Engineering Professionals Act, 2003, in one of the following categories:

- Candidate Engineer;
- Candidate Engineering Technologist;
- Candidate Engineering Technician, and
- Candidate Certificated Engineer.
- III. Persons performing consultancy work for financial gain.
- A Task Team was established to determine the competency profile for the Mine Overseer/Middle Management qualification;
- Legal opinion was received relating to the interpretation of reference to "the public interest" in the Engineering Profession Act, 200 (Act No 46/200) and the Occupational Health and Safety Act, 1996 (Act No 29/1996 as amended)
- Referral was established to the ESGB of the concern relating to the future of the N4 to N6 Technical qualification(s) as a possible progression/articulation route to the certificated engineer/manager.
- Finalisation and submission of the following competency standards to SAQA:
  - "Stage 1: 480 Credit National Degree: Engineering Technology at Level 7 on the NQF (B. Tech (Eng.)), for Engineering Technologists", and
  - "Stage 1: 360 Credit National Diploma: Engineering Technology at Level 6 on the NQF (N. Dip (Eng.), for Engineering Technicians"
- Appropriate amendment of Version 3 of the Rules for the Recognition of Voluntary Association approved by the ECSA ExCo which would enable participating MPAs active in the SA M&MS to be recognized by ECSA as a Voluntary Association.
- Initiatives within the SGG: Certificated Engineers to review/finalise the Stage 2 competency profile and learning assumed to be in place (Stage 1 learning outcomes) for certificated engineers.

Your Association continues to encourage members to join ECSA, in this way it will be in a position to influence ECSA'S decision making process.

# OCCUPATIONAL, HEALTH AND SAFETY POLICY COMMITTEE (OH&SPC)

Your Association is represented on the Occupational, Health and Safety Policy Committee of the Chamber of Mines by Mr W Marais, with Mr M J Lourens from the South African Colliery Engineers' Association serving as his alternate.

This body is the main employer caucus for the Mining Regulations Advisory Committee and various issues related to occupational health and safety are tabled for comment, before mandates are passed on to Mining Regulations Advisory Committee members.

The main focus area of the committee has been:

- Review the SIMRAC levy system: A number of proposals and options have been tabled and investigated. A final discussion will be taken during December 2004 as to a new levy system for 2005.
- 2. Draffing of Regulations: A number of new regulations have been draffed, promulgated and old regulations repealed. The main topic of discussion has been on the necessity of statutory appointments versus appointments based on risk assessments. (Statutory regulatory mechanisms versus outcome based regulations).

The DME (Chief Inspector) is of the view that certain minimum requirements must be stipulated in order to set basic standards.

A decision has to be taken to allow a shift towards setting some basic minimum standards versus the principles around which the MHSA was designed.

This has impacted on the drafting of some regulations, specifically those requiring engineering expertise.

The Association continued to provide technical input and advice on flameproofing, non flameproof underground vehicles, definition on hazardous areas and risk assessment.

#### **OPENCAST, UNDERGROUND AND PLANT USERS SUB-COMMITTEES**

The Opencast, Underground and Plant Users Sub-Committees' meetings were revamped in order to stimulate attendance during the year aimed at improving communication between different mines and mining houses. Meetings which did have some good attendance benefited from a good cross-pollination of ideas and solutions to problems on mines which proved beneficial to those concerned. However some meetings were cancelled during the year and attendance varied from meeting to meeting.

The Council again calls on members to support these sub- committees and encourage participation from shift bosses and foremen.

# PAPERS AND TECHNICAL NOTES

Whilst it is noted that technical notes were presented during the year at Regional meetings, the call for the preparation and presentation of full technical papers has largely gone unheeded, and your Council would again urge that this matter receive urgent attention from members as these technical papers, besides being a valuable source for the dissemination of information, also serve as an educational tool for future mining engineers.
